March is the 9th month in our fiscal year, which is highlighted by very little revenue, totaling \$1,645.50. In addition to the spirit store sales during the month there were a handful of new members to the club, and we received a donation in honor of Tracey Lavine doing guest bartending at Rollhouse.

From an expense standpoint, the primary purpose of the payments were for teams. In total, there were disbursements to fourteen teams, and that number includes the middle school. The spirit store's expense was for inventory purposes and we have paid our final February fundraiser bills.

The total assets as of March 31,, 2023 is \$143,959.61; this represents a decrease in assets of (\$15,071.21) from February 2023. For comparison, at this point last year (March 2022), we had \$143,276.18 in assets. March 2023 was a worse from a performance standpoint than March 2022 as a month by \$12,58742.

# **Committee Reports**

Advertising/program – getting some additional advertisers. Probably getting Crumble Cookie to advertise

Parent Rep – need to update, also ask for more from them on the social media posting side

Scholarships – had long discussion regarding funds to be given this year as well as revamping the scholarship applications for next year. Scholarship committee requesting \$23,000 which would award all applicants various amounts. Committee was prepared to drop the lowest 16 applicants to make it \$19,000 if not approved. Note: no budget was set ahead of time for the committee. Request for \$23,000 was granted. Motioned by Jill Frazier, seconded by Andrea Pitzel. Was stated for next year that a budget needed to be set before scholarship committee started the process. Also scholarship applicant readers felt the applicantions relied too heavily on grades and volunteering and that is not the focus of SAB. Also agreed to meet and go over scholarship applications and make changes as needed to more favor athletics.

**Addendum to scholarships (4-13-23):** during virtual discussion by board members, it was noted that scholarship fund approval must be voted on by board members. Previous motions to pass were by members that are not board members. Rob Farley motioned to approve \$23,000 for scholarships. Cory Lance seconded motion. Erica Kanj and Nancy Westrich in favor. Adam Zelwin opposed. Motion to grant \$23,000 for scholarships passes.
