July is the first month of our fiscal year, and it is typically the time of the year when we see an increase in transactions for the club. While the golf outing is in August, July is the month where we start to see the entry fees and sponsorships for it come in. July is also a month where the fiscal year '24 membership fees start to come in.

From an expense standpoint, the largest expense was the booster club acting as the "bank" for the football team to pay the team fees for their John Carroll camp. We have a plan in place with the football team to have the team fees paid back through a combination of selling the "discount cards" and personal funds from the players. The spirit store expense is for inventory for the upcoming year. The lacrosse expense is a combination of conference champion shirts and shirts parents wanted to buy that we were reimbursed for. The Tennis expense was for their conference shirt.

The total assets as of July 31, 2023 is \$101,112.00; this represents a decrease in assets of (\$3,167.81) from June 2023. For comparison, at this point last year (July 2022), we had \$111,919.33 in assets. If we excluded the football expense, which we expect to be reimbursed for, we would have had a slightly better July than the previous year.
