**Shortly after month end, we cut checks that totaled \$17,750.00 for Scholarships, as of the May booster meeting we have approximately \$124,924.27 in total assets.

Summary:

Total Expenses for the month of April was \$1,117.06. Top expenses for the month of April:

- 1. February Fundraiser \$403.81
- 2. Boys Lacrosse \$357.50
- 3. Football \$55.00

As we get to the last quarter of the school year, activity for the Club starts to slow down in March and April. We will see some pick up in May for end of the year activities, but April is one of our slower months. This past month I'm hopeful that we saw the last of the activity to close out the february fundraiser. From a revenue standpoint, we had some items purchased from the Spirit Store, some families purchased yard signs, and we had a new family join the club.

From an expense standpoint, we had our final expenses for the February Fundraiser and we bought the lacrosse team t-shirts for the boys lacrosse team in support of their salute to service day where they threw shirts out to youth kids and paid fees for a football team fundraiser.

The total assets as of April 30, 2025 is **\$142,674.27**; this represents an increase in assets of \$42,973.96 from April 2024. *Please note the caveat posted above in regards to the \$17,750 in checks cut right after the month for May scholarships*. For comparison, at this point last year (April

2024), we had \$99,700.10 in assets. The significant increase in assets this year can mostly be attributable to having a February Fundraiser in '25 whereas we did not have one in 2024.
